Whereas, the J&K Public Service Commission, vide Notification No. 11- PSC (DR-P) OF 2023 dated: 05.04.2023, advertised the said posts for selection; **and,**

Whereas, written test was conducted on 22.10.2023. Whereas, the viva-voce of candidates was conducted on 8th of November, 2023 with the assistance of Expert from outside of the UT.
