Whereas, Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 13.04.2022, referred three (03) posts (OM: 01, RBA: 01, SC: 01) of Assistant Professor, Electrical Engineering, to the J&K Public Service Commission, for selection of suitable candidates; and,

Whereas, the J&K Public Service Commission, vide Notification No. 11- PSC (DR-P) OF 2023 dated: 05.04.2023, advertised the said posts for selection; and,

Whereas, written test was conducted on 22.10.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2023/80 dated: 09.11.2023 in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended up-to-date; and,

Whereas, 15 candidates were called for interview; and,

Whereas, the viva-voce of candidates was conducted on 14th of November, 2023 with the assistance of Experts from outside of the UT.

Now, therefore, on the basis of the performance in the written test, interview, and other related parameters, in pursuance of Rule 45 of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as Annexure-"A" to this Notification.
