Subject: Provisional Select List for the post of Assistant Professor, Electrical Engineering, in GCET, in Higher Education Department - Disposal of representations.

Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 13.04.2022, referred three (03) posts (OM=01, RBA=01, SC=01), of Assistant Professor, Electrical Engineering in GCET, in Higher Education Department, to the J&K Public Service Commission, for selection. The posts were advertised vide Notification No. 11-PSC (DR-P) of 2023 dated: 05.04.2023; **and,**

Whereas, the written test was conducted on 22.10.2023 and the result thereof was declared vide Notification No. PSC/Exam/S/2023/80 dated: 09.11.2023. The viva-voce of the candidates was conducted on 14.11.2023; **and,**


Whereas, the provisional Select List was issued vide Notification No. 96-PSC (DR-S) of 2023 dated 18.11.2023, subject to objections, to be received within five days; **and,**

Whereas, in response to the above Notification, (01) objection has been received from Mr. Wakeeh Ul Islam Dar, stating therein that he applied for the post of Assistant Professor under RBA category, and uploaded the same alongwith other documents but the category certificate was expired that time, and his renewed certificate was issued after the cut off date. He has requested for consideration of his renewed RBA category certificate; **and,**

Whereas, As per the J&K Public Service Commission (Business & Procedure) Rules, 2021, any document possessed by the candidate upto the cut off date fixed in the advertisement Notification shall only be taken into account. The candidate produced two (02) RBA certificates at the time of Interview. One RBA certificate has been issued in his favour on 18.04.2014 expiring, thereby, on 17.04.2019 (i.e before the cut off date viz. 04.05.2023) and another certificate has

been issued in his favour on 22.09.2023 (i.e after the cut off date) meaning thereby that from 18.04.2019 upto the cut of date of the advertisement Notification, the candidate was not in possession of a valid RBA certificate.

Now, therefore, the representation is disposed off, being devoid of any merit and is, hence, rejected.
