Subject: Select List for the post of Librarian in GMC-Handwara & Udhampur in Health & Medical Education Department-Disposal of representation thereof

Notice Dated: 07.02.2024

Whereas, the Health & Medical Education Department vide letter No. MEGztd/270/2022 dated 01.11.2022, referred two (02) posts, under OM Category, of Librarian one each in GMC Handwara and Udhampur, to J&K Public Service Commission for selection; **and**

Whereas, the Commission vide Notification No. 30-PSC (DR-P) of 2023 dated 31.12.2022, notified these posts for selection; **and**,

Whereas, the written test was conducted on 29.10.2023 and the result thereof was declared vide notification No. PSC/Exam/s/2023/84 dated 14.11.2023. The interview/viva-voce of the eligible candidates was conducted on 17.11.2023; **and**

Whereas, The Provisional Select List was issued vide Notification No. 99-PSC (DR-S) of 2023 dated 18.11.2023 with the stipulation that the objections, if any, be submitted to the Commission within five days, for examination and disposal; **and**,

Whereas, in response the Commission received one objection; **and**,


Whereas, the summary of the representation and its consideration is given in the table hereunder:-

Sr. No.	Name of the Official	Details of the objection	Remarks
01	Jasmeet Kour	The candidate has stated in her objection that she was not shortlisted for viva-voce and after the declaration of the Provisional Selection List it has been seen that the selected candidate got 62.71 points in written test. According to revised answer key her actual score was 82.5 and according to JKPSA point system it is 70.95. But she has been neither shortlisted for viva voce not selected. It may be a little mistake for JKPSA, and has requested to investigate the matter on priority basis to ensure the transparency.	The objection was examined and it has been observed that the written examination had 100 marks for 100 questions and not 120 marks. Calculation of points was obtained out of 120, which proportionately, decreased total points for each candidate without affecting relative merit. The weight age of written test was 86 points. The cut off for shortlisting for interview was 83 points. The candidate scored merit less than

			the cut-off, as such, was not called for interview.

Now, therefore, the above representation is disposed off, being devoid of any merit and is, hence, rejected.
