APPENDIX "B"

REGULATIONS FOR THE MEDICAL EXAMINATION OF CANDIDATES FOR ADMISSION TO THE JAMMU AND KASHMIR CIVIL SERVICE (JUDICIAL)

These regulations are intended merely for the guidance of Medical Board and not meant to restrict their discretion in any way.

- 1. To be passed medically fit for admission to the Jammu and Kashmir Civil Service (Judicial) a candidate must be in good mental and bodily health and free from any physical defect likely to interfere with the efficient performance of his duties and member of the service.
- 2. The following conditions will be observed in connection with the test for acuteness of vision.

VISION OF CANDIDATE

(a) No candidate will be accepted whose vision is less than

Better eyeWorse eyev=6/6 Reads 6v-6/12 Reads 1

Spectacles will be allowed for either upto plus 5 (D or minus 5) D provided that there are no morbid changes in the funds.

- (b) In myopia if there is a posterior stamphyloma the spectacles must not exceed 2.5 D in either eye.
- (c) In case of astigmatism the combined lenses must not exceed 5 Diopters and there should be no funds changes.
- (d) Squint or any other morbid condition of the eyes of the lids of either eye liable to the risk of aggravation or recurrence will cause the rejection of the candidate.
- (a) Each eye must have a full field of vision as tested by hand movement.
- (b) Any defect in colour vision will be noted but will not cause rejection of the candidate.
- (c) In case of doubt of serious abnormality the opinion of the opthalmic specialist will be obtained.
- (d) No candidate will be accepted whose standard of vision does not come upto the specified requirements without the use of constant glasses.
- 3. The urine (passed in presence of the Examiner) should be examined and the result recorded.
- 4. The following additional points should be observed:-
 - (a) That the candidate's hearing in each ear is good and that there is no sign of disease of the ear;
 - (b) That his speech is without impediment;
 - (c) That his teeth are in good order and that he is provided with dentures where necessary for effective mastication (well filled teeth will be considered as sound);

- (d) That his chest is well formed and his chest expansion sufficient and that his heart and lungs are sound;
- (e) That there is no evidence of abdominal diseases;
- (f) That he is not ruptured;
- (g) That he does not suffer from phdrocela a severe degree of varicocele varicose voins or pile.
- (h) That his limbs, hands and feet are well formed and development that there is free and perfect motion of all his joints;
- (i) That he does not suffer from any inverterate skin;
- (j) That there is no congenial malformation or defect;
- That he does not bear traces of acte or chronic disease pointing to an imparity constitution;
- (I) That he bears marks of efficient vaccinations and evidence or revaccination within the last 12 months.

When any defect is found it must be noted in the certificate and the medical examination should state his opinion whether or not it is likely to interfere with the efficient performance of the duties which will be required of the candidate. If the condition is remediable by operation it should be stated.

The following intimation is made for the guidance of the Medical Examiner:-

- (1) In the medical examination of the candidates Medical Officers are specially required to use tact and judgement and to take proper precaution to secure privacy with the object of removing any objection which may be made by individual to stripping.
- (2) Should a candidate object to the exposure of his person for detection of haemorrhoids, veneral diseases, hernia and disease of the testicles; scrotum and rectum the candidate must if this examinations in his case is in the opinion of the board necessary be rejected.
- (3) The opinion of the board accepting or rejecting a candidate is final and cannot be questioned on any ground. The board is debarred from disclosing to any candidate permanently unfit the reasons for his rejection. In these cases their opinion and report is to be treated as strictly confidential and for the information of Government only. Where however, the Board detects temporary defects amenable to treatment the candidate may be so informed in order that he may have the defect remedied and present himself for re-examination.

- (4) No person will be deemed qualified for admission to the service unless he satisfies the Government that he has no disease constitutional affection or bodily informity unfitting him or likely to unfit him for that service.
- (5) It should be understood that the question of fitness involves the future as well as present and the main object of medical examination is to secure continuous effective service and in the case of candidates for permanent appointment to prevent early pension or payment in case of premature death. It is at the same time to be noted that the question is one of the likelihood of continuous, of effective service and that the rejection of candidate need not be advised on account of the presence of a defect which is only a small proportion of cases is found to interfere with continuous effective service.

The candidate must make the statement required below prior to his medical examination and must sign the declaration appended thereto. His attention is specially directed to the warning contained in the note below:-

- (1) State your name in full
- (2) State your age and birth place
- (3) (a) Have you ever had smallpox in intermittent or any other fever, enlargement of glands, spitting of blood, asthma, inflammation of lungs, heart disease, fainting attacks, rehumatism or appendicitation.
 - (b) Any other disease or accident requiring confinement to bed and medical or surgical treatment, or
 - (a) Have you ever been rejected by a Medical Board or a duly constituted Medical Authority.
- (4) When were you last vaccinated ?
- (5) Have you or any of your nearer relations been effected with consumption scorefuls, gout, asthma, fits epilepsy or insanity ?
- (6) Have you suffered from any or nervousness due to over work or any other cause.

Subject: Result of Jammu and Kashmir Civil Services (Judicial) Examination 2023- deployment of candidates for Medical Examination thereof.

Notification No.: PSC/Exam/2024/04 Dated: 03.04.2024

Whereas, the Department of Law, Justice & Parliamentary Affairs, vide letter No. Law-JUD/88/2021-10 dated 26.08.2023, referred 69 posts of Civil Judge (Junior Division), to the J&K Public Service Commission for being filled up through the Competitive Examination; and,

Whereas, these posts were advertised by the Commission vide Notification No. 35-PSC(DR-P) of 2023 dated 27.08.2023; and,

Whereas, J&K Civil Services (Judicial) [Preliminary] Examination-2023, was conducted on **08.10.2023** in which **3266** candidates appeared in full; and,

Whereas, as per the criteria fixed by the Commission, a total of 1162 candidates were declared to have qualified for the Mains Examination vide Notification No. PSC/Exam/S/2023/64 dated 13.10.2023; and,

Whereas, J&K Civil Services (Judicial) [Mains] Examination-2023 was conducted from 08.11.2023 to 20.11.2023; and,

Whereas, as per the criteria fixed by the Commission, 208 candidates were declared to have qualified for interview vide Notification No. PSC/Exam/S/2024/01 dated 06.03.2024; and,

Whereas, the viva-voce of these candidates was conducted w.e.f 19.03.2024 to 03.04.2024 at JKPSC Office, Resham Ghar Colony, Bakshi Nagar, Jammu; and,

Whereas, one candidate bearing Roll No.9100666 was not interviewed as the candidate failed to produce the EWS certificate. As a consequence, the candidate bearing Roll No.9101362, being next in order of merit, was called for interview under the said category;and,

Whereas, the Commission in its meeting held on 03.04.2024, decided to declare the result of the candidates who appeared in the interview by notifying their aggregate marks while publishing a list of the candidates to be summoned for Medical Examination in accordance with the relevant rules.

Now, therefore, in pursuance of the provisions contained in Jammu and Kashmir Civil Services (Judicial) Recruitment Rules, 1967 read with SRO No. 5 dated 04.01.1968 and SRO 254 of 2017 dated 20.06.2017, J&K Public Service Commission (Conduct of Examination) Rules 2022 and J&K Reservation Rules, 2005 (SRO 294):

- i) The result of candidates, who appeared in the viva-voce (interview) of J&K Civil Services (Judicial) Examination-2023, is hereby notified as per Annexure-I to this notification.
- ii) Consequent upon (i) above, 69 candidates as per Annexure-II of this notification, on the basis of their aggregate merit in the written examination and viva-voce (interview), have qualified for Medical Examination and are directed to report to the respective Medical Boards constituted/or to be constituted in Government Medical College Jammu & Srinagar for conduct of their Medical Examination as per proforma, in accordance with rules on the subject. The Medical Board, date and venue shall be notified separately.

The candidates recommended for medical examination will have to pay a fee as prescribed, before Medical check-up.

Note:

- 1. Mere calling a candidate for Medical Examination shall not confer any right on him/her to be recommended for selection.
- 2. Detailed marks cards shall be available on the website of the Commission after completion of the examination process and after forwarding the select list to the Government for making appointments.
- 3. The lists notified as Annexure-I & II to this notification are provisional and subject to the outcome of the writ petition(s), if any, pending before any Competent Court of jurisdiction.
