Whereas, the J&K Public Service Commission, vide Notification No. 31-PSC (DR-P) of 2022 dated 30.12.2022, advertised the said post for selection; and,

Whereas, in response, 1482 application forms were received for the said post; and,

Whereas, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 43 (ii) of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended up to date, a written test was conducted on 29.10.2023 at Srinagar and Jammu; and,

Whereas, 188 candidates were called for interview, which was held on 17/18.11.2023. Since most of the candidates were common to the notifications, as such, only 82 candidates were called for interview. 06 candidates remained absent.

Now, therefore, on the basis of the performance in the written test, interview, and other related parameters, in pursuance of Rule 43 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure-"A"** to this Notification.

Consequent upon the details given here-in-above, Provisional Select List of the candidates as per merit, is given in **Annexure-B** to this Notification.

Note:-

1. The Commission reserves the right to have certificates/documents of the candidates verified, if at any later stage found expedient to do so. The Selection of the candidates is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.
2. The selection is provisional and objections, if any, may be submitted to the Commission within five days for examination and disposal. No claim, whatsoever, shall be entertained after five days from the date of issuance of Notification.
3. 41 posts remained vacant due to non-availability of candidates or candidates having not crossed the bench mark as envisaged in Rule

50 of the J&K Public Service Commission (Business & Procedure) Rules, 2021. The details are given below:


