Whereas, the H&ME Department, vide letter No MEGztd/270/2022 dated 01.11.2022, referred twelve (12) posts of Casualty Medical Officer, each in GMC Handwara and GMC Udhampur, to the J&K Public Service Commission, as per the following breakup:

Whereas, the J&K Public Service Commission, vide Notification No. 30-PSC (DR-P) of 2022 dated 30.12.2022, advertised the said posts; **and,**

Whereas, the written test was conducted on 29.10.2023 and, viva-voce of the candidates was conducted on 17/18.11.2023; **and,**


Whereas, the Select List was notified vide Notification No. 04-PSC (DR-S) of 2024 dated 12.04.2024; **and,**

Whereas, the Select List was provisional, subject to objections, which were to be received within five days; **and,**

Whereas, one representation from Mr. Tahir Yaseen Bhat S/o Mohmmad Yaseen Bhat has been received, wherein he has requested that his candidature may be considered for the post of Casualty Medical Officer, Handwara, instead of GMC Udhampur as he has secured 48.93 points and deserves to be considered for GMC, Handwara on the basis of higher merit; **and,**

Whereas, the representation has been examined and it has been found that Mr. Tahir Yaseen Bhat has applied only against the post of GMC Udhampur, under item No. 70, and has not applied against the post of Casualty Medical Officer, Handwara, where Item No was 34.

Now, therefore, the representation of Tahir Yaseen Bhat S/o Mohmmad Yaseen Bhat, after having been examined/considered, is disposed of being devoid of merit.
