Whereas, the written test was conducted on 03.11.2023, and 27 candidates were declared to have qualified the written test vide Notification No. PSC/Exam/S/2024/20 dated 29.04.2024; and,

Whereas, upon scrutiny of the documents, it has been found that Dr. Suboor Ahmad Naik S/o Gh Nabi Naik under Roll No. 7000003, does not possess the requisite qualification for the post.

Now, therefore, the candidature of the above named candidate is hereby rejected for the post of Assistant Professor, Microbiology, in GMC Anantnag, Baramulla, Doda, Rajouri & Udhampur.
