Whereas, Health & Medical Education Department, vide letter No. MEGAZ-187/2014 dated 18.08.2021 read with ME-GZtd/317/2021 (e-office), dated 14.03.2022, ME-GZtd/56/2022 (e-office), dated 06.04.2022 and ME-GZtd/21/2022 (e-office), dated 07.07.2022, referred **seven (07)** posts of **Assistant Professor, Anatomy**, under various categories in GMC Anantnag (OM:01), GMC Baramulla (OM: 01), GMC Doda (OM: 01, RBA: 01), GMC Kathua (OM:01) and GMC Rajouri (OM: 01, RBA: 01) to the J&K Public Service Commission, for selection of suitable candidates; **and,**

Whereas, the J&K Public Service Commission, vide Notification No. 28 -PSC (DR-P) of 2023 dated 08.06.2023, advertised the said posts for selection; **and,**

Whereas, a written test was conducted on 29.10.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/15 dated: 25.04.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; **and,**

Whereas, five (05) candidates were shortlisted for interview for GMC Anantnag, 05 for GMC Baramulla and 02 for GMC Kathua. Since, 05 candidates were common, as such, only 07 candidates had to be called for interview; **and,**

Whereas, no candidates were available for short-listing/selection for remaining posts/colleges; **and,**

Whereas, the viva-voce of candidates was conducted on 08.07.2024, with the assistance of Experts from outside of UT.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 44 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.
