Whereas, Health & Medical Education Department, vide Nos, ME-Gztd/246/2022-02 (CC: 7037074) dated 26.07.2023, and letter No: Me-Gztd/246/2022 e-office dated 05.12.2022, referred **four (04)** posts of **Assistant Professor, Dentistry** under open category, one each in GMC Anantnag, Doda, Kathua and Rajouri to the J&K Public Service Commission, for selection of suitable candidates; **and,**

Whereas, the J&K Public Service Commission, vide Notification No. 35-PSC (DR-P) of 2023 dated 03.08.2023, advertised the said posts for selection; **and,**

Whereas, a written test was conducted on 29.10.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/15 dated: 25.04.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; **and,**

Whereas, five (05) candidates were shortlisted each for GMC Anantnag, Doda, Kathua and Rajouri. Since, five candidates had applied against multiple posts, as such, only 07 candidates had to be called for interview; **and,**

Whereas, the viva-voce of candidates was conducted on 09.07.2024, with the assistance of Experts from outside of UT.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 44 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.


