The result of the written test was declared vide Notification No. PSC/Exam/S/2024/20 dated: 29.04.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; *and*,

Whereas, five (05) candidates were called for interview for GMC Anantnag, 02 for GMC Baramulla, 07 for GMC Doda, 07 for GMC Handwara, 06 for GMC Kathua, 08 for GMC Rajouri and 03 for GMC Handwara. Since, some candidates had applied
