Whereas, the posts were advertised, vide Notification(s) No. 06-PSC (DR-P) of 2023 dated 15.05.2023; and,

Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 24.03.2023, among others, again referred 10 posts (OM=03, SC=01, ST=01, ALC/IB=01, Social Cost, 01, RBA=01,PSP=01, EWS=01) of Assistant Professor Mathematics, in Higher Education Department, for selection; and

Whereas, these posts were advertised, vide Notification(s) No. 17-PSC (DR-P) of 2023 dated 15.05.2023, and

Whereas, the written test was conducted on 05.11.2023, and 68 candidates were declared to have qualified the written test for both the above notifications, vide Notification No. PSC/Exam/S/2024/08 dated 01.04.2024; and,

Whereas, upon scrutiny of the documents, it has been found that Mr. Waseem Ali Mir S/o Ali Mohd Mir does not possess the requisite relevant qualification for the said post.

Now, therefore, the candidature of the Mr. Waseem Ali Mir S/o Ali Mohd Mir is hereby rejected.
