Rejection of candidature for the post of Assistant Professor Education, in Higher Education Department.

Whereas, the Higher Education Department, vide letter HE/Coll/Coord/Apptt/A.P/2021 dated 05.07.2021 and No. HED-GAZ/85/2022-04 dated 13.03.2022, among others, referred 06 posts (OM=03, RBA=01, SC=01, ST=01) of Assistant Professor Education, in Higher Education Department, for selection; and,

Whereas, the posts were advertised, vide Notification No. 06-PSC (DR-P) of 2023 dated 01.03.2023; and,

Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 24.03.2023, among others, again referred 04 posts (OM=02, ALC/IB=01, EWS=01) of Assistant Professor Education, in Higher Education Department, for selection; and

Whereas, these posts were advertised, vide Notification No. 17-PSC (DR-P) of 2023 dated 15.05.2023, and

Whereas, the written test was conducted on 05.11.2023, and 45 candidates were declared to have qualified the written test for both of the above notifications, vide Notification No. PSC/Exam/S/2024/08 dated 01.04.2024; and,

Whereas, upon scrutiny of the documents, it has been found that Mr. Mohd Haneef Kumar S/o Mohd Shaban Kumar is over aged, as such is not eligible for the said post.

Now, therefore, the candidature of the Mr. Mohd Haneef Kumar S/o Mohd Shaban Kumar is hereby rejected.
