Subject: Provisional Select List for the post of Assistant Professor, General Medicine in Government Medical Colleges Anantnag, Baramulla, Doda, Handwara, Kathua, Rajouri and Udhampur in Health & Medical Education Department.

Whereas, the Health & Medical Education Department, vide letter Nos, MEGAZ-187/2014 dated 18.08.2021 read with ME-GZtd/317/2021 (e-office), dated 14.03.2022, ME-Gztd/56/2022 (e-office), dated 06.04.2022 and ME-Gztd/21/2022 (e-office), dated 07.07.2022, referred **two (02)** posts of **Assistant Professor, General Medicine**, one each in GMC Anantnag and Baramulla under Open category, to the J&K Public Service Commission, for selection of suitable candidates; **and,**

Whereas, the said posts were advertised vide Notification No. 28-PSC (DR-P) of 2023 dated 08.06.2023. The cut-off date for determination of eligibility was fixed as 30.06.2023; **and,**

Whereas, again the Department vide letters NOs. ME-Gztd/246/2022-02 (CC: 7037074) dated 26.07.2023, and letter No: Me-Gztd/246/2022 e-office dated 05.12.2022 referred **nineteen (19)** posts in various GMCs to the J&K Public Service Commission, with the following break-up, for selection of suitable candidates:-

GMC Anantnag (RBA: 01), Baramulla (RBA: 01), Doda (OM: 02, RBA: 01, SC: 01), Kathua (OM: 02, RBA: 01, SC: 01), Handwara (OM: 01, SC: 01), Rajouri (OM: 02, SC: 01), Udhampur (OM: 02, RBA: 01, SC: 01)

Whereas, these posts were advertised vide Notification No. 35-PSC (DR-P) of 2023 dated 03.08.2023. The cut-off date for determination of eligibility was fixed as 19.08.2023; **and,**

Whereas, a written test was conducted on 03.11.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/20 dated: 29.04.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; **and,**

Whereas, ten (10) candidates were called for interview for GMC Anantnag, 10 for GMC Baramulla, 17 for GMC Doda, 05 for GMC Handwara, 16 for GMC Kathua, 12 for GMC Rajouri and 18 for GMC Udhampur. Since, some candidates had applied against more than one post, as such, only 28 candidates had to be called for interview; **and,**

Whereas, the viva-voce of candidates was conducted on 16.07.2024, with the assistance of Experts from outside of UT.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 44 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.


Note:-
