Subject: Selection of candidates for the post of Assistant Professor, Physical Medicine & Rehabilitation, in Government Medical Colleges Anantnag, Baramulla, Doda, Handwara, Kathua, Rajouri and Udhampur in Health & Medical Education Department

Whereas, the Health & Medical Education Department, vide letter Nos, ME-Gztd/246/2022-02 (CC: 7037074) dated 26.07.2023, and letter No: MEGztd/270/2022 dated 01.11.2022 referred two (02) posts of **Assistant Professor, Physical Medicine & Rehabilitation**, one each in GMC Handwara and Udhampur under Open Category, to the J&K Public Service Commission, for selection of suitable candidate; and,

Whereas, the said post was advertised vide Notification No. 30-PSC (DR-P) of 2022 dated 30.12.2022. The cut-off date for determination of eligibility was fixed as 31.01.2023; **and**,

Whereas, again the Department vide letters NOs. MEGztd/246/2022 dated 05.12.2022 referred **five (05)** posts of **Assistant Professor, Physical Medicine & Rehabilitation**, one each in GMC Anantnag, Baramulla, Doda, Kathua and Rajouri under Open category, to the J&K Public Service Commission, for selection of suitable candidates; **and**,

Whereas, these posts were advertised vide Notification No. 31-PSC (DR-P) of 2022 dated 30.12.2022. The cut-off date for determination of eligibility was fixed as 31.01.2023; **and**,

Whereas, a written test was conducted on 03.11.2024. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/20 dated: 29.04.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; **and**


Whereas, three (03) candidates were called for interview for GMC Anantnag, 02 for GMC Baramulla and 01 for GMC Handwara. Since, some candidates had applied against more than one post, as such, only 04 candidates had to be called for interview; **and**,

Whereas, the viva-voce of candidates was conducted on 22.07.2024, with the assistance of Experts from outside of UT; **and**,

Whereas, 03 candidates remained absent or were not eligible.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 44 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.

Consequent upon the details given here-in-above, the only interviewed candidate, namely, Sheikh Irfan Bashir S/o Sheikh Bashir Ahmad, BD No. 01, Roll No. 7600001 could not cross the benchmark as envisaged in Rule 51 of J&K Public Service Commission (Business & Procedure) Rules, 2021. Hence, no Provisional Select list is drawn.
