**Subject: Provisional Select List for the post of Epidemiologist Cum Assistant Professor in Government Medical Colleges Baramulla, Doda, Handwara, Kathua, Rajouri and Udhampur in Health & Medical Education Department.**

Whereas, the Health & Medical Education Department, vide letter Nos, MEGztd/270/2022 dated 01.11.2022 referred two (02) posts of **Epidemiologist Cum Assistant Professor**, one each in GMC Handwara and Udhampur under Open Category, to the J&K Public Service Commission, for selection of suitable candidates; *and,*

Whereas, the said posts were advertised vide Notification No. 30-PSC (DR-P) of 2022 dated 30.12.2022. The cut-off date for determination of eligibility was fixed as 31.01.2023; *and,*

Whereas, again the Department vide letters NOs. MEGztd/246/2022 dated 05.12.2022 referred **two (02)** posts of **Epidemiologist Cum Assistant Professor**, one each in GMC Baramulla and Kathua under Open category to the J&K Public Service Commission, for selection of suitable candidates:-

Whereas, these posts were advertised vide Notification No. 31-PSC (DR-P) of 2022 dated 30.12.2022. The cut-off date for determination of eligibility was fixed as 31.01.2023; *and,*

Whereas, also the Department, vide letter Nos, MEGAZ-187/2014 dated 18.08.2021 read with ME-GZtd/317/2021 (e-office), dated 14.03.2022, ME-Gztd/56/2022 (e-office), dated 06.04.2022 and ME-Gztd/21/2022 (e-office), dated 07.07.2022, referred **two (02)** posts of **Epidemiologist Cum Assistant Professor**, one each in GMC Doda and Rajouri under Open category, to the J&K Public Service Commission, for selection of suitable candidates; *and,*

Whereas, these posts were advertised vide Notification No. 28-PSC (DR-P) of 2023 dated 08.06.2023. The cut-off date for determination of eligibility was fixed as 30.06.2023.

Whereas, a written test was conducted on 29.10.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/15 dated: 25.04.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; *and,*

Five (05) candidates were called for interview for GMC Baramulla, 05 for GMC Doda, 05 for GMC Handwara, 05 for GMC Kathua, 05 for GMC Rajouri and 05 for GMC Udhampur. Since, some candidates had applied against more than one post, as such, only 12 candidates had to be called for interview; **and,**

Whereas, the viva-voce of candidates was conducted on 19.07.2024, with the assistance of Experts from outside of UT.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 44 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.
