Whereas, the Department of Skill Development, vide their communication No. Edu/Tech/Genl/61/2019 dated: 30.09.2020, referred two (02) posts, one each under Open and RBA category of Lecturer-I, Electronics and Communication, to the J&K Public Service Commission, for selection of suitable candidates; and,

Whereas, the posts were advertised vide Notification No. 06-PSC (DR-P) of 2022 dated: 24.01.2022. The cut-off date for determination of eligibility was fixed as 23.02.2022; and,

Whereas, in pursuance of Rule 31 & 43(i) of J&K Public Service Commission (Business & Procedure) Rules, 2021, a written test was conducted on 14.11.2022 at Srinagar and Jammu; and,

Whereas, the result of the written examination was declared on 19.12.2022 and 11 candidates were called for interview/viva-voce; and,

Whereas, the viva-voce of candidates was conducted on 26.07.2024, with the help of experts from outside of the UT.


