- 2. Whereas, the Provisional official answer key was notified and uploaded on the official website of the Commission for information of the candidates on 09.06.2024, inter-alia notifying that, if any candidate feels that the keys to any of the questions is wrong/incorrect, he/she may prefer а representation/objection on the prescribed proforma to the Controller of Examinations within a period of three days from the date of its notification, i.e. upto 12.06.2024 (5:00 p.m.) along with documentary proof /evidence and the fee of Rs.500/- per question; and
- 3. Whereas, in response to the said notification, number of objections/ representations were received by the J&K Public Service Commission against Provisional Answer Keys issued; and
- 4. Whereas, all the objections/representations were referred to the Committee(s) of Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time, for Independent Expert opinion; and
- 5. Whereas, the independent team of Experts have recommended changes in the Provisional Official Keys in respect of the said papers;

Now, therefore, in view of the above and on the basis of opinion of the independent teams of Experts, it is hereby notified that:-
