Rejection of candidature for the post of Assistant Professor Mathematics, in Higher Education Department.

Whereas, the Higher Education Department, vide letter No.HE/Coll/Coord/Apptt/A.P/2021 dated 05.07.2021 and No. HED-GAZ/85/2022-04 dated 13.03.2022, among others, referred 07 posts (OM=04, RBA=01, SC=01, ST=01) of Assistant Professor, Mathematics, in Higher Education Department, for selection; and,

Whereas, the posts were advertised, vide Notification No. 06-PSC (DR-P) of 2023 dated 15.05.2023; and,

Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 24.03.2023, among others, again referred 10 posts (OM=03, SC=01, ST=01, ALC/IB=01, Social Cost, 01, RBA=01, PSP=01, EWS=01) of Assistant Professor Mathematics, in Higher Education Department, for selection; and,

Whereas, these posts were advertised, vide Notification No. 17-PSC (DR-P) of 2023 dated 15.05.2023, and,

Whereas, the written test was conducted on 05.11.2023, and 68 candidates were declared to have qualified the written test provisionally, for both the above notifications, vide Notification No. PSC/Exam/S/2024/08 dated 01.04.2024; and,

Whereas, upon scrutiny of the documents, it has been found that Mr. Nusrat Ahmed Dar S/o Ghulam Nabi Dar R/o Matipora Herpora Mattan (Roll No. 580027) has submitted three EWS certificates. The certificates dated 21.06.2019 and 20.07.2020, are on Central Format, valid for the year 2019-2020 and 2020-2021 respectively. The third certificate dated 23.06.2023 has been issued after the cut of date viz 16.06.2023, as such cannot be entertained. It was expressly mentioned in the Notification that the last date for receipt of application forms shall be the cut of date for determination of eligibility.

Now, therefore, the candidature of the Mr. Nusrat Ahmed Dar S/o Ghulam Nabi Dar R/o Matipora Herpora Mattan (Roll No. 580027) is hereby rejected for the post of Assistant Professor, Mathematics, in Higher Education Department. No claim whatsoever shall be entertained after the stipulated period.
