Rejection of candidature for the post of Assistant Professor Education, in Higher Education Department.

Whereas, the Higher Education Department, vide letter No.HE/Coll/Coord/Apptt/A.P/2021 dated 05.07.2021 and No. HED-GAZ/85/2022-04 dated 13.03.2022, among others, referred 06 posts (OM=03, RBA=01, SC=01, ST=01) of Assistant Professor, Education, in Higher Education Department, for selection; and,

Whereas, the posts were advertised, vide Notification No. 06-PSC (DR-P) of 2023 dated 01.03.2023; and,

Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 24.03.2023, among others, again referred 04 posts (OM=02, ALC/IB=01, EWS=01) of Assistant Professor Education, in Higher Education Department, for selection; and,

Whereas, these posts were advertised, vide Notification No. 17-PSC (DR-P) of 2023 dated 15.05.2023, and,

Whereas, the written test was conducted on 05.11.2023, and 45 candidates were declared to have qualified the written test for both of the above notifications, vide Notification No. PSC/Exam/S/2024/08 dated 01.04.2024; and,

Whereas, upon scrutiny of the documents, it has been found that Ms. Gurashish Kour D/o Balbir Singh R/o Houe No. 166A Sector 6 Nanak Nagar Jammu (Roll No. 4100760) has submitted three EWS category certificates, 1st dated 15.04.2021 valid for the year 2021-22, other two certificates dated 27.06.2023 and 19.07.2024, are both on Central Format, and issued after cut of date viz 16.06.2023. It was expressly mentioned in the Notification that the last date for receipt of application forms shall be the cut of date for determination of eligibility. Therefore, these certificates cannot be entertained.

Now, therefore, the candidature of the Ms. Gurashish Kour D/o Balbir Singh R/o Houe No. 166A Sector 6 Nanak Nagar Jammu (Roll No. 4100760), is hereby rejected for the post of Assistant Professor, Education, in Higher Education Department.
