Rejection of candidature for the post of Assistant Professor (Physics), in Higher Education Department.

Whereas, the Higher Education Department, vide letter No. HE/Coll/Coord/Apptt/A.P./2021 dated 05.07.2021 and HED-GAZ/85/2022-04 dated 13.04.2022 among other subjects, referred 01 post (OM=01) of Assistant Professor (Physics) in Higher Education Department, to the J&K Public Service Commission for selection; and,

Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 24.03.2023 among other subjects, again referred 28 posts (OM=13, SC=03, ST=03, ALC=1, SLC=1, RBA=3, PSP=1, EWS=3) of Assistant Professor (Physics) in Higher Education Department, to the J&K Public Service Commission for selection; and,

Whereas, the posts were advertised, vide Notification Nos. 06-PSC (DR-P) of 2023 dated 01.03.2023 and 17-PSC (DR-P) of 2023 dated 15.05.2023; and,

Whereas, a common written test was conducted on 05.11.2023 and vide Notification No. PSC/Exam/S/2024/08 dated 01.04.2024, 05 candidates against Notification No. 06-PSC (DR-P) of 2023 dated 01.03.2023 and 86 candidates against Notification No. 17-PSC (DR-P) of 2023 dated 15.05.2023 were declared to have qualified for viva-voce; and,

Whereas, after declaration of the result, one candidate namely Mr. Mashkoor Ahmed Dar represented that he has applied under both notifications but was shortlisted against notification No. 06-PSC(DR-P) of 2023 dated 01.03.2023 only, and requested for inclusion in the list of candidates shortlisted for viva-voce under Notification No. 17-PSC (DR-P) of 2023 dated 15.03.2023 as well; and,

Whereas, the result of written examination has been declared vide Notification No. PSC/Exam/S/2024/08 dated 01.04.2024 and the applicant has figured in the result notification against notification No. 06-PSC(DR-P) of 2023 dated 01.03.2023 under Roll No. 6200013; and,

Whereas, on scrutiny of the records and documentary evidence produced by the said candidate it was found that he had applied against both the above mentioned advertisement notifications; and

Whereas, 39 candidates have been shortlisted for viva-voce against 13 posts under OM category,under notification No. 17-PSC (DR-P) of 2023 dated 15.05.2023. By including the applicant in the said result notification, one of the already shortlisted candidate bearing Roll No. 6200044 (last in merit of shortlisted candidates under OM category) is to be excluded from the result notification.

Therefore, in view of the above, Mr. Sajad Ahmad Bhat S/o Gh. Hassan Bhat, bearing RollNo.6200044 figuring in Annexure-F at S.No.14 in the result Notification No. PSC/Exam/S/2024/08 dated: 01.04.2024 is hereby deleted *abinitio*.
