Whereas, the J&K Public Service Commission, vide Notification No. 06-PSC (DR-P) OF 2023 dated: 01.03.2023, advertised the said posts for selection; and,

Whereas, again the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 24.03.2023, referred **03 posts (OM: 01, SC: 01, PSP: 01)** of Assistant Professor, Music, to the J&K Public Service Commission, for selection of suitable candidates; and,

Whereas, the J&K Public Service Commission, vide Notification No. 17-PSC (DR-P) OF 2023 dated: 15.05.2023, advertised the said posts for selection; and,

Whereas, written test was conducted on 05.11.2023 and the result was declared vide Notification No. PSC/Exam/S/2024/08 dated: 01.04.2024 in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended up-to-date; and,

Whereas, the viva-voce of candidates was conducted on 6th & 7th of August, 2024 with the assistance of Experts from outside of the UT.

Whereas twenty six (26) candidates were called for interview against Notification dated 01.03.2023 and 10 candidates against Notification dated 15.05.2023. Since some candidates were shortlisted for both the Notifications, as such, only 27 candidates had to be called for interview.

Now, therefore, on the basis of the performance in the written test, interview, and other related parameters, in pursuance of Rule 45 of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure-**"**A**" to this Notification.
