Whereas, Higher Education Department, vide letter No. HE/Coll/Coord/Apptt/A.P/2021 dated 05.07.2021 and HED-GAZ/85/2022-04 dated 13.04.2022, referred **twelve (12) posts (OM: 06, RBA: 02, SC: 01, ST: 01, EWS: 01 and ALC/IB: 01) of Assistant Professor, Music (Instrument/ Vocal)**, to the J&K Public Service Commission, for selection of suitable candidates; *and*,

Whereas, the J&K Public Service Commission, vide Notification No. 06-PSC (DR-P) OF 2023 dated: 01.03.2023, advertised the said posts for selection; *and*,

Whereas, again the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 24.03.2023, referred **03 posts (OM: 01, SC: 01, PSP: 01) of Assistant Professor, Music**, to the J&K Public Service Commission, for selection of suitable candidates; *and*,

Whereas, the J&K Public Service Commission, vide Notification No. 17-PSC (DR-P) OF 2023 dated: 15.05.2023, advertised the said posts for selection; *and*,

Whereas, written test was conducted on 05.11.2023 and the result was declared vide Notification No. PSC/Exam/S/2024/08 dated: 01.04.2024 in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended up-to-date; *and*,

Whereas, the viva-voce of candidates was conducted on 6th & 7th of August, 2024 with the assistance of Experts from outside of the UT.


Whereas twenty six (26) candidates were called for interview against Notification dated 01.03.2023 and 10 candidates against Notification dated 15.05.2023. Since some candidates were shortlisted for both the Notifications, as such, only 27 candidates had to be called for interview.

Now, therefore, on the basis of the performance in the written test, interview, and other related parameters, in pursuance of Rule 45 of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure-"A"** to this Notification.

Consequent upon the details given here-in-above, Provisional Select List of the candidates as per merit, is given in **Annexure-"B"** to this Notification.

Note:-

1. The Commission reserves the right to have certificates/documents of the candidates verified, if at any later stage found expedient to do so. The Selection of the candidates is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.
2. The selection is provisional and objections, if any, may be submitted to the Commission within five days for examination and disposal. No claim, whatsoever, shall be entertained after five days from the date of issuance of Notification.
3. One post each under EWS and ALC/IB category in Notification No. 06-PSC (DR-P) of 2023 and one post each in OM and PSP category in Notification No. 17-PSC (DR-P) of 2023 remained unfilled due to non availability of candidates/ the candidate not crossing the benchmark as required under Rule 51 of J&K Public Service Commission (Business & Procedure) Rules, 2021.
