Whereas, the Health & Medical Education Department, vide letter Nos, ME-Gztd/246/2022-02 (CC: 7037074) dated 26.07.2023, and letter No: Me-Gztd/246/2022 e-office dated 05.12.2022 referred **three** posts of **Assistant Professor, Orthopaedics**, one each in GMC Anantnag and GMC Doda under Open Category and one in GMC Rajouri under RBA category, to the J&K Public Service Commission, for selection of suitable candidates; **and**,

Whereas, a written test was conducted on 29.10.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2023/15 dated: 25.04.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; **and**,

Whereas, five (05) candidates were called for interview for GMC Anantnag, 05 for Doda and 02 for GMC Rajouri; **and**,

Whereas, the viva-voce of candidates was conducted on 09.08.2024, with the assistance of Experts from outside of UT.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 44 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.
