Whereas, the result of the J&K Combined Competitive (Mains) Examination 2023 was declared vide Notification No. PSC/Exam(S)/2024/35 dated 09.07.2024 and 274 Candidates were declared to have qualified the (Mains) Examination provisionally; and,
