Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 13.04.2022, among others, referred 02 posts (OM=01, RBA=01) of Assistant Professor (Structural Engineering) in the School of Architecture, in Higher Education Department, to the J&K Public Service Commission for selection; and,

Whereas, the posts were advertised, vide Notification No. 15-PSC (DR-P) of 2023 dated 02.05.2023; and,


Whereas, the written test was conducted on 17.03.2024, and 05 candidates were declared to have qualified the written test, vide Notification No. PSC/Exam/S/2024/24 dated 08.05.2024; and

Whereas, upon scrutiny of the documents, it was found that Mr. Zeeshan Manzoor S/o Manzoor Ahmad Maqsood, Roll No. 4200023, has submitted the experience certificate as Civil Engineer in a private company viz Hassan Road Construction Co Pvt Ltd.

Whereas, vide Notice dated 26.07.2024, the candidate was advised to submit the above experience certificate dully authenticated /countersigned by the District/Divisional/State Authority as envisaged in Rule 45 of J&K Public Service Commission (Business & Procedure) Rules, 2021.

Whereas, the candidate has failed to get the Experience certificate, issued in his favour by Hassan Road Construction Co. Pvt. Ltd, Vide No. HRCC/Misc/1248/2017 dated 23.12.2017, authenticated/countersigned and, instead has submitted another Experience certificate issued in his favour by Civil Construction Division JKPCD, Kupwara vide No. CCD/PDC/K/Adm/480 dated 26.07.2024. The said Experience certificate has been issued after the cut of date, as such cannot be entertained.

Now, therefore, the candidature of Mr. Mr. Zeeshan Manzoor S/o Manzoor Ahmad Maqsood, Roll No. 4200023 is hereby rejected for the post of Assistant Professor, Structural Engineering, in School of Architecture, in Higher Education Department, notified vide Notification No.15-PSC(DR-P) of 2023 dated 02.05.2023.
