Subject: Provisional Select List for the post of Assistant Professor, General Surgery, in GMC Baramulla, Doda, Handwara, Kathu and Rajouri, in Health & Medical Education Department.

Notification No. 34-PSC (DR-S) of 2024 Dated: 11.09.2024

Whereas, Health & Medical Education Department, vide letter Nos. MEGAZ-187/2014 dated 18.08.2021 read with ME-GZtd/317/2021 (e-office), dated 14.03.2022, ME-Gztd/56/2022 (e-office), dated 06.04.2022 and ME-Gztd/21/2022 (e-office), dated 07.07.2022 referred **one (01)** post of **Assistant Professor, General Surgery**, in GMC Baramulla under Open category, to the J&K Public Service Commission, for selection of suitable candidate. J&K Public Service Commission, vide Notification No. 28 -PSC (DR-P) of 2023 dated 08.06.2023, advertised the said post for selection; *and*,

Whereas, Health & Medical Education Department again, vide letter Nos. ME-Gztd/246/2022-02 (CC: 7037074) dated 26.07.2023, and letter No: Me-Gztd/246/2022 e-office dated 05.12.2022, referred **nine (09)** posts in various GMCs to the J&K Public Service Commission, for selection of suitable candidates with the following break-up:-

GMC Anantnag (RBA: 01), Baramulla (SC: 01), Doda (OM: 01, RBA: 01, SC: 01), Handwara (SC: 01) under 1<sup>st</sup> Special Drive, Kathua (OM: 01), Rajouri (RBA: 01, SC: 01). The posts were advertised vide Notification No. 35-PSC (DR-P) of 2023 dated 03.08.2023. The cut-off date for determination of eligibility was fixed as 19.08.2023. Pursuant upon the communication of the Health & Medical Education Department bearing No. ME-Gztd/7/2022 (CC: 112966) dated 25.06.2024 and 08.08.2024, one post under RBA category in GMC Anantnag was withdrawn ab-initio vide this Commission's Notice dated 03.09.2024.

Whereas, a written test was conducted on 03.11.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/20 dated: 29.04.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; *and*,

Five (05) candidates were shortlisted for interview for GMC Anantnag, 05 for GMC Baramulla, 14 for GMC Doda, 01 for GMC Handwara, 05 for GMC Kathua and 08 for GMC Rajouri. Among 05 candidate who were earlier shortlisted for post under RBA category in GMC Anantnag (RBA post stood withdrawn in view of the Commissions Notice dated 03.09.2024) in Notification NO. 35-PSC (DR-P) of 2023, among others only 03 were called for interview as they had applied against other posts/colleges as well. Moreover, some candidates were common to both the Notifications and as such only 20 candidates were called for interview; *and*,

Whereas, the viva-voce of candidates was conducted on 10.09.2024, with the assistance of Experts from outside of UT.



Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 44 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure-A** to this Notification.

Consequent upon the details given here-in-above, Provisional Select List of the candidates as per merit, is given in **Annexure-B** to this Notification.

## Note:-

- The Commission reserves the right to have certificates/documents of the candidates verified, if at any later stage found expedient to do so. The selection of the candidates is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.
- 2. The selection is provisional and objections, if any, may be submitted to the Commission within five days for examination and disposal. No claim, whatsoever, shall be entertained after five days from the date of issuance of Notification.
- 3. Two posts one each in GMC Baramulla and GMC Handwara under SC category remained vacant due to non-availability of the candidates.
