Whereas, the Higher Education Department, vide letter No. HE/Coll/Coord/ Apptt. /A.P/2021 dated 05.07.2021 and HED-GAZ/85/2022-04 dated: 13.04.2022, referred (12) posts (OM: 06, RBA: 02, SC: 01, ST: 01, EWS: 01, ALC/IB: 01) of Assistant Professor Music/Music (Instrument/Vocal), to the J&K Public Service Commission, for selection; and,

Whereas, the J&K Public Service Commission, vide Notification No. 06-PSC (DR-P) of 2023 dated: 01.03.2023, advertised the said posts; and,

Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated: 24.03.2023, again referred (03) posts (OM: 01, SC: 01, PSP: 01,) of Assistant Professor Music/Music (Instrument/Vocal) to the J&K Public Service Commission, for selection; and

Whereas, the J&K Public Service Commission, vide Notification No. 17-PSC (DR-P) of 2023 dated: 15.05.2023, advertised the said posts; and,

Whereas, the written test was conducted on 05.11.2023 and the result of the written test was declared vide Notification No. PSC/Exam/S/2024/08 dated: 01.04.2024; and,

Whereas, the viva-voce of the candidates was conducted on 6th & 7th of August, 2024; and,

Whereas, a provisional Select List was issued on 08.08.2024; and,

Whereas, the Select List was provisional, subject to objections, if any, which were to be received within five days; and,

Whereas, two representations have been received from:-



Whereas, the objections raised in the representations and their consideration is given here-in-under:

01	Ms. Aditya Bhanu	I have applied under, SC category, in both Notifications viz. 06-PSC (DR-P) of 2023 and 17-PSC (DR-P) of 2023 dated 15.05.2023 for (01) post, each in both Notifications. The Commission has kept one post under OM category	The candidates are shortlisted in their respective categories in which they have applied. Shifting of category is allowed on individual merits of the case (she does not reach the

I may be considered against the vacant OM post as no other candidate is there after me who has cleared in both the notifications.</p> <p>I also submitted some of my awards in my given documents to Commission, they have not awarded me any marks for that also. I requested them also for marks which were to be given for awards as I had National Award from ALL INDIA RADIO, KHAZANA FESTIVAL (MUMBAI) and many more which I submitted there.</p>	<p>benchmark for OM Category)</p> <p>The candidate has submitted certificate regarding her participation in Air Music competition conducted by All India Radio where she has won the First Prize. This certificate does not qualify for treating as National Award.</p>
02	Mr. Waseem Raja	<p>I had applied for the post of AP-Music in both the Notifications viz 17-PSC(DR-P) of 2023 dated 15.05.2023 and 06-PSC(DR-P) of 2023 dated 01.03.2023. I was shortlisted for interview in Notification No. 06-PSC(DR-P) of 2023 dated 01.03.2023 but could not be selected. However, I was not shortlisted for interview for Notification No. 17-PSC(DR-P) of 2023 dated 15.05.2023 as only four candidates were shortlisted against one post which is against the J&K PSC (Business & Procedure) Rules, 2021. It is requested that my candidature may be considered against Notification No. 17-PSC(DR-P) of 2023 dated 15.05.2023 also in order to meet the criteria of 1:5 ratio of J&K PSC (Business & Procedure) Rules.</p>	<p>As per records, against (01) post, under OM category, in Notification No.17-PSC(DR-P) of 2023 dated 15.05.2023, 04 candidates were shortlisted from OM category, while as the 5th candidate, whose main category was RBA had applied as OM/RBA, as such shortlisted under OM category. Thus the ratio of 1:5 has very much been followed.</p>

Now, therefore, the above representations are disposed off, being devoid of any merit and are hence, rejected.
