1. Whereas, the J&K Public Service Commission conducted the **Written Test for filling up of the post of Assistant Professor (Physiology) in Health and Medical Education Department, on 21.06.2024; and**
2. Whereas, the Provisional official answer key was notified and uploaded on the official website of the Commission for information of the candidates on 21.06.2024, inter-alia notifying that, if any candidate feels that the key(s) to any of the questions is wrong/incorrect, he/she may prefer a representation/objection on the prescribed proforma to the Controller of Examinations within a period of three days from the date of notification along with documentary proof/evidence and the fee of Rs.500/- per question; and
3. Whereas, in response to the said notification, number of objections/representations were received by the J&K Public Service Commission against Provisional Official Answer Key issued; and
4. Whereas, all the objections/representations were referred to the Committee of Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time, for Independent Expert opinion; and
5. Whereas, the independent team of Experts have recommended changes in the Provisional Official Answer Key in respect of the said paper;

Now, therefore, in view of the above and on the basis of opinion of the independent teams of Experts, it is hereby notified that:-

- a) The changes recommended by the Committee of Experts are hereby adopted and the Final Official Answer Key is annexed to this notification as **Annexure A** in the discipline of **Physiology** in Health and Medical Education Department. In terms of Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022 as amended upto date, the marks allocated to the deleted questions ***shall be individually added to the marks secured by the individual candidates to ensure that the mark(s) allocated for the question paper as a whole remain unchanged***, at the time of calculation/compilation of award sheet before the declaration of the result;
- b) The amount deposited @ Rs 500/- per question is also hereby released in respect of genuine/correct representations and same shall be transferred through RTGS in individual account of candidates.
