
Whereas, the Higher Education Department vide letter No.HE/Coll/Coord/Appt/A.P./2021 dated 05.07.2021 and HED-GAZ/85/2022-04 dated 13.04.2023, among others, referred 05 posts (OM=03, RBA=01, SC=01) of Assistant Professor, BBA/MBA & Management, in Higher Education Department, to the J&K Public Service Commission for selection; and,

Whereas, the post was advertised, vide Notification No. 06-PSC (DR-P) of 2023 dated 01.03.2023, for the domiciles of Union Territory of Jammu & Kashmir, possessing the prescribed qualification; and,

Whereas, the written test was conducted on 09.06.2024, and 05 candidates were declared to have qualified the written test vide Notification No. PSC/Exam/S/2024/44 dated 30.07.2024; and,

Whereas, upon scrutiny of the documents, it has been found that EWS category certificate submitted by Mr. Syed Jahanzaib Geelani S/o Syed Zaffar Ahmad Geelani (Roll No. 3200154), has been issued on 01-04.2023 i.e after cut of date viz 31.03.2023. It was expressly mentioned in the Notification that the last date for receipt of application forms shall be the cut of date for determination of eligibility. Therefore, the said category certificate cannot be entertained.

Now, therefore, the candidature of the Mr. Syed Jahanzaib Geelani S/o Syed Zaffar Ahmad Geelani (Roll No. 3200154), for the post of Assistant Professor, BBA/MBA & Management, in Higher Education Department is hereby rejected. If the candidate feel aggrieved with rejection of his candidature, he may represent before the Appellate Authority of the Commission with documentary evidence in support of his claim within 10 days from the date of issuance of this Notice. No claim whatsoever shall be entertained after the stipulated period.
