Whereas, the written test was conducted on 27.08.2023 and the result of the written test was declared vide Notification No. PSC/Exam/S/2023/55 dated: 20.09.2023; and,

Whereas, the viva-voce of the candidates was conducted on 01.10.2023 and 04.10.2023; and,

Whereas, a provisional Select List was issued on 09.08.2024; and,

Whereas, the Select List was provisional, subject to objections, if any, which were to be received within five days; and,

		<p>This Paper is derived from his Master's dissertation work for which he had already received academic Credits during his master program. As per JKPSC guidelines, papers based on dissertation work shouldn't be considered for additional marks in the Selection process. (Rule 45 of JK PSC)</p>	
02	Mr. Nirmal Kumar	<p>That in the provisional selection List he has not been awarded the point of teaching experience whereas he has two academic sessions teaching experience and submitted the experience certificate in prescribed format at the time of interview. According to provisional selection list his written score is 45.94 whereas according to final answer key issued by JK PSC his written score is 46.50.</p> <p>Therefore taking into account of the above mentioned points kindly reexamine the selection list and award the above said points in his favour.</p>	<p>As per the check sheet prepared at the time of interview, duly signed by the candidate, he has not submitted any experience certificate at the time of interview, as such has not been awarded any points for experience. As per records the candidate has secured only 45.94 points in the written test.</p>
