Whereas, the Higher Education Department, vide letter No.HE/Coll/Coord/Apptt/A.P/2021 dated 05.07.2021 and No. HED-GAZ/85/2022-04 dated 13.03.2022, among others, referred 07 posts (OM=04, RBA=01, SC=01, ST=01) of Assistant Professor, Mathematics, in Higher Education Department, for selection; and,

Whereas, the posts were advertised, vide Notification No. 06-PSC (DR-P) of 2023 dated 15.05.2023; and,

Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 24.03.2023, among others, again referred 10 posts (OM=03, SC=01, ST=01, ALC/IB=01, Social Cost, 01, RBA=01, PSP=01, EWS=01) of Assistant Professor Mathematics, in Higher Education Department, for selection; and,

Whereas, these posts were advertised, vide Notification No. 17-PSC (DR-P) of 2023 dated 15.05.2023, and,

Whereas, the written test was conducted on 05.11.2023, and 68 candidates were declared to have qualified the written test provisionally, for both the above notifications, vide Notification No. PSC/Exam/S/2024/08 dated 01.04.2024; and,


Whereas, upon scrutiny of the documents, it was found that EWS category certificate, issued vide No. TV/BCG/Veri/64 dated 02.09.2024 dated 23.05.2023, submitted by Ms. Sonia Devi D/o Ram Paul R/o Vill Badali, Teh Vijaypur, Distt Samba (Roll No. 5800261) has been issued for jobs in the Central Government, as such was not considered for the jobs in UT of J&K.

Whereas, report was called from Tehsildar Vijaypur, vide letter No. PSC/DR/AP-Math/Hr. Edu./2024 dated 12.07.2024 and letter No. PSC/DR/AP-Math/Hr. Edu./2024 dated 02.09.2024, as to whether the EWS category certificate, issued vide letter No. TV/BCG/Veri/64 dated 02.09.2024 in favour of Ms. Sonia Devi D/o Ram Paul R/o Vill Badali, Teh Vijaypur, Distt Samba can be considered for the jobs in UT of J&K.

Whereas, Tehsildar Vijaypur, vide letter No.TV/BCG/Veri/64 dated 02.09.2024, has conveyed that the EWS category certificate issued vide letter No.

JK-Rev-EWS/2023/04881 dated 23.05.2023 in favour of Ms. Sonia Devi D/o Ram Paul R/o Vill Badali, Teh Vijaypur, Distt Samba, has not been issued in terms of SRO-518 dated 02.09.2019. therefore, the said certificate cannot be considered for jobs in the Government of UT of J&K.

Now, therefore, the candidature of the Ms. Sonia Devi D/o Ram Paul R/o Vill Badali, Teh Vijaypur, Distt Samba (Roll No. 5800261), under EWS category, for the post of Assistant Professor, Mathematics, in Higher Education Department, is hereby rejected.
