Whereas, the Higher Education Department, vide letter No.HE/Coll/Coord/ Apptt/A.P/2021 dated 05.07.2021 and No. HED-GAZ/85/2022-04 dated 13.03.2022, among others, referred 11 posts (OM=06, RBA=01, SC=01, ST=01, EWS=01, ALC/IB=01 of Assistant Professor Chemistry, in Higher Education Department, for selection; and

Whereas, the posts were advertised vide Notification No. 06-PSC (DR-P) of 2023 dated 01.03.2023; and

Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 13.04.2022, among others, again referred 27 posts (OM=13, SC=02, ST=03, ALC/IB=01, SLC=01, RBA=03, PSP=02, EWS=02,) of Assistant Professor, Chemistry, in Higher Education Department; and

Whereas, these posts were advertised, vide Notification No. 17-PSC (DR-P) of 2023 dated 15.05.2023; and

Whereas, the written test was conducted on 27.08.2023, and the result thereof was declared, vide Notification No. PSC/Exam/S/2023/53 dated 18.09.2023. The viva voce of candidates, who qualified the Written Test in both the Notifications, was conducted on 3<sup>rd</sup>, 4<sup>th</sup> and 5<sup>th</sup> October, 2024 with the assistance of Experts from outside of the UT; and

Whereas, provisional Select List was issued on 23.08.2024; and,

Whereas, the Select List was provisional, subject to objections, if any, which were to be received within five days; and,

Whereas, five (05) representations have been received from:-



Whereas, the objections raised in the representations and their consideration is given here-in-under:

S. No	Name of the representee	Objection	Remarks/disposal
01	Dr.Manpreet Kaur	My result has been withheld as my EWS category certificate was on Central Format. I am submitting the EWS certificate which is on UT format issued by Tehsildar R.S. Pora. Therefore, my result may be released.	Representation considered.

02	Mr. Shokat Hussain	Only three candidates were shortlisted for interview against two posts in ALC/IB category, one each, in Notification No. 06-PSC(DR-P) of 2023 and 17-PSC(DR-P) of 2023, instead of 06 candidates as per ratio of 1:3.	Shortlisting has been done as per rules. Three (03) candidate who had applied in both the Notifications got shortlisted as per their merit against both the Notifications, as such were called for interview.
03	Shahbaz Ahmad Lone	a) My result has been withheld due to the accreditation certificate for post doctorate. I am as submitting the accreditation certificate issued by d Association of Indian Universities, New Delhi R dated 28th August, 2024. My result may kindly be declared.  b) Mr. Ahmad Illahie Tantry has only NET/SET. He deserves only 02 points, while as, he has been given weightage of 03 points, i.e NET/SET/JRF. He has no JRF.	(a) Representation considered.  (b) Matter under examination.
04	Salman Jameel	a) Ahmad Illahie Tantray, Roll No. 1060262 has only NET and SET, as such deserves only 02 points, while as he has been given 03 marks equal to JRF.  b) Mr. Sanjay Kumar, Roll No. 1060496 has i been awarded 02 marks for 04 research S publications, some of which are already present in his thesis for which he should not be awarded any marks. It is requested to get his research publications and thesis re-evaluated.	(a) Matter under examination.  (b) The representation against Mr. Sanjay Kumar is not specific, as such merits no consideration.
05	Pawandeep Kour	My candidature in the Provisional Selection list has been shown as rejected. Kindly inform why my candidature has been rejected.	Candidature has been rejected on the basis of the report received from Tehsildar Rajouri, vide communication OQ/612 dated 23.08.2024, that the certificate has been issued for the purpose of Central Government services and admissions to educational Institutions under Gol only as the applicant is covered/eligible under PSP category also.
