Subject: Filling up of Gazetted Vacancies in various Govt. Medical Colleges-2023 in Health and Medical Education Department – Revised Result of Written Test reg;

Notification No. PSC/Exam/S/2024/62

Dated: 09.10.2024

Whereas, the Health and Medical Education Department vide requisition letters dated 14.03.2022, 06.04.2022 and 07.07.2022, among other posts also requested to fill the 04 posts of Assistant Professor (Physiology) under OM category in GMC Anantnag, GMC Doda, GMC Kathua and GMC Rajouri; and,

Whereas, vide Notification No. 16-PSC(DR-P) of 2022 dated 12.07.2022, among others, the Commission notified the above referred four (04) posts of Assistant Professor (Physiology) for inviting online applications from suitable candidates possessing prescribed qualification for the said post; and,

Whereas, the Notification No. 16-PSC(DR-P) of 2022 dated 12.07.2022 was withdrawn later vide Notification No. 18-PSC(DR-P) of 2023 dated 25.05.2023 and it was intimated to all the candidates that the posts will be advertised afresh; and,

Whereas, vide Notification No. 28-PSC(DR-P) of 2023 dated 08.06.2023, among other posts, the above mentioned posts of Assistant Professor (Physiology) for GMC Doda, GMC Kathua and GMC Rajouri were advertised afresh except for GMC Anantnag, wherein it has been mentioned that candidates who have earlier applied for the said post against the previous advertisement notification No. 16-PSC (DR-P) of 2022 dated 12-07-2022 need not apply again; and,

Whereas, in addition to above, the Health and Medical Education Department vide requisition letters dated 05.12.2022 and 26.07.2023, forwarded 07 (OM:1, RBA:6) more posts of Assistant Professor (Physiology) in GMC Anantnag, GMC Baramulla, GMC Doda, GMC Handwara, GMC Kathua, GMC Rajouri and GMC Udhampur for being filled up in accordance with the relevant rules of the Department; and,

Whereas, accordingly vide Notification No. 35-PSC(DR-P) of 2023 dated 03.08.2023, among others, the Commission notified these seven (07) posts of Assistant Professor (Physiology) for inviting online applications from suitable candidates possessing prescribed qualification for the said post; and

Whereas, vide Notice dated 07.06.2024, all the candidates were informed that a common written test against both the notifications for the post of Assistant Professor (Physiology) shall be held on 21.06.2024; and,

Whereas, the written examination for the post of Assistant Professor (Physiology) was conducted on 21.06.2024 and the result of written examination was declared vide notification No. PSC/Exam/S/2024/59 dated 18.09.2024 against notification No. 28-PSC (DR-P) of 2023 dated 08.06.2023 and 35-PSC (DR-P) of 2023 dated 03.08.2023 in respect of GMC Anantnag, GMC Doda, GMC Kathua and GMC Rajouri; and,

Whereas, after declaration of the result, a candidate namely Dr. Mohita Singh represented before the Commission for non-inclusion of her name against the notification No. 28-PSC(DR-P) of 2023 dated 08.06.2023; and,

Whereas, on perusal of her representation and record it has been found that she had applied under notification no. 16-PSC(DR-P) of 2022 dated 12.07.2022 for the said post which was later withdrawn by the Commission vide notification No. 18-PSC (DR-P) of 2023 dated 25.05.2023; and,

Whereas, while preparation of result of the said written examination, inadvertently the candidates who had applied against notification No. 16-PSC(DR-P) of 2022 dated 12.07.2022 were not taken into consideration; and,

Whereas, now, after taking into consideration the candidates who had applied against notification No.16-PSC(DR-P) of 2022 dated:12.07.2022, a revised result of written examination for the post of Assistant Professor (Physiology) against notification No.28-PSC(DR-P) of 2023 dated: 08.06.2023 has been prepared.

Now, therefore, in view of the aforesaid position and in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examinations) Rules, 2022 as amended upto date read with Rule 31 and 44 of J&K Public Service Commission (Business & Procedure) Rules, 2021 and in supersession of the notification No. PSC/Exam/S/2024/59 dated 18.09.2024, the candidates as per **Annexure-A, B, C & D** to this notification are hereby declared to have qualified for the Oral Test/ Viva Voce for the post of **Assistant Professor (Physiology)** in Health and Medical Education Department on the basis of their performance in the Written Test which was held on 21.06.2024. The notification with respect to the dates of Interview/Viva-Voce shall be notified separately.

Note:

- i. For checking the result, candidates are advised to access the official website of the Commission i.e. <http://www.jkpsc.nic.in>.
- ii. The candidature of candidates shown in Annexures to this notification is purely provisional. The documents of the candidates will be verified at the time of interview and in case any discrepancy with regard to age/qualification/experience and other eligibility conditions is noticed at the time of interview or thereafter, the candidate shall not be allowed to appear in the interview or where the candidate has already appeared in the interview, the candidature shall be deemed to have been cancelled ab-initio.
- iii. Only eligible candidates, possessing requisite qualification prescribed under rules, shall be allowed to appear in the Oral Test/Viva-Voce subject to the condition that they are within the prescribed age limit on the cut-off date.
- iv. The candidates shall produce their original certificates/testimonials on the date of oral test/Viva-Voce.

This is subject to the outcome of writ petition, if any, pending disposal before any competent Court of Law.
