Subject: Filling up of the post of Horticulture Development Officer in Agriculture Production Department (Horticulture) – Revised Result of Written Test reg;

Notification No. PSC/Exam/S/2024/63

Dated: 10.10.2024

Whereas, the Agriculture Production Department (Horticulture) vide communication No. Horti-Gaz/8/2021(98948) dated 03.04.2023 and 24.05.2023 requested to fill the Forty-One (41) posts of Horticulture Development Officer in accordance with the J&K Gazetted Service Recruitment Rules issued vide SRO-161 of 2002 with following prescribed qualification:

“M.Sc. Horticulture. In case of non-availability, B.Sc. Horticulture/ B.Sc. Agriculture”.

Whereas, vide Notification No. 29-PSC(DR-P) of 2023 dated 09.06.2023, the Commission notified the above referred Forty-One (41) posts of Horticulture Development Officer for inviting online applications from eligible candidates possessing prescribed qualification for the said post; and,

Whereas, vide Notice dated 17.05.2024, all the candidates were informed that the written test for the post of Horticulture Development Officer shall be held on 29.05.2024; and,

Whereas, the written examination for the post of Horticulture Development Officer was conducted on 29.05.2024 and the result of written examination was declared vide notification No. PSC/Exam/S/2024/40 dated 29.07.2024; and,

Whereas, while preparation of result of the said written examination, the prescribed qualification for the said post was inadvertently misinterpreted and the result was declared; and,


Whereas, the matter was deliberated in the Commission and it was decided to recast the result as per the prescribed qualification for the post and, accordingly, the revised result of the written examination for the post of Horticulture Development Officer has been prepared as per the prescribed qualification.

Now, therefore, in view of the aforesaid position and in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examinations) Rules, 2022 read with Rule 31 and 43(ii) of J&K Public Service Commission (Business & Procedure) Rules, 2021 as amended upto date and in supersession of the notification No. PSC/Exam/S/2024/40 dated 29.07.2024, the candidates as per **Annexure-A** to this notification are hereby declared to have qualified for the Oral Test/Viva Voce for the post of **Horticulture Development Officer** in Agriculture Production Department (Horticulture) on the basis of their performance in the Written Test which was held on 29.05.2024. The notification with respect to the dates of Interview/Viva-Voce shall be notified separately.

Note:

- i. For checking the result, candidates are advised to access the official website of the Commission i.e. <http://www.jkpsc.nic.in>.
- ii. The candidature of candidates shown in Annexure –A is purely provisional. The documents of the candidates will be verified at the time of interview and in case any discrepancy with regard to age/qualification/experience and other eligibility conditions is noticed at the time of interview or thereafter, the candidate shall not be allowed to appear in the interview or where the candidate has already appeared in the interview, the candidature shall be deemed to have been cancelled *ab-initio*.
- iii. Only eligible candidates, possessing requisite qualification prescribed under rules, shall be allowed to appear in the Oral Test/Viva-Voce subject to the condition that they are within the prescribed age limit on the cut-off date.
- iv. The candidates shall produce their original certificates/testimonials on the date of oral test/Viva-Voce.

This is subject to the outcome of writ petition, if any, pending disposal before any competent Court of Law.


