Subject: Provisional Select List for the post of Assistant Professor, Obsts. & Gynae, in GMC Anantnag, Baramulla, Doda, Handwara, Kathua, Rajouri and Udhampur in Health & Medical Education Department. – Disposal of representation.

Whereas, the H&ME Department, vide letter Nos MEGAZ-187/2014 dated 18.08.2021 read with ME-Gztd/317/2021 (e-office), dated 14.03.2022, ME-Gztd/56/2022, (e-office) dated 06.04.2022 and ME-Gztd/21/2022 (e-office), dated 07.07.2022, referred four (04) posts of **Assistant Professor, Obsts & Gynae**, one each, in GMC Baramulla and Kathua, under OM category, and two (02) post in GMC Doda, one each in Open and RBA category, to the J&K Public Service Commission; and,

Whereas, the J&K Public Service Commission, vide Notification No. 28-PSC (DR-P) of 2023 dated 08.06.2023, advertised the said posts; and,

Whereas, the Department, again vide letter Nos. ME-Gztd/246/2022-02 (CC:7037074) dated 26.07.2023, and ME-Gztd/246/2022 e-office dated 05.12.2022, referred ten (10) posts in various GMCs to the J&K Public Service Commission, with following breakup:-

GMC Anantnag (OM=01, SC=01), Baramulla (RBA= 01), Doda (SC=01), Rajouri (SC=01, RBA=01-1st Special Drive), Handwara (SC=01-1st Special drive), Udhampur ([RBA=01, SC=01] under 1st Special Drive and Kathua (RBA=01-1st Special Drive)

Whereas, the J&K Public Service Commission, vide Notification No. 35-PSC (DR-P) of 2023 dated 03.08.2023, advertised the above said posts; and,

Whereas, the written test was conducted on 03.11.2023 and, viva-voce of the candidates was conducted on 09.09.2024; and,

Whereas, the Select List was notified vide Notification No. 33-PSC (DR-S) of 2024 dated 10.09.2024; and,


Whereas, the Select List was provisional, subject to objections, which were to be received within five days; and,

Whereas, one representation from Dr. Deepika Sharma (Roll No. 6600059), has been received against the Provisional Select List, stating that she was shortlisted for an interview at GMC Anantnag and secured 53.40 points, which is higher than the selected candidate for GMC Kathua, who had scored 53.21 points only, and requested to reconsider her selection against the post/vacancy of Assistant Professor, Obsts &

Gynae in GMC Kathua under OM category, keeping in view higher merit than the selected candidate; and

Whereas, the representation has been examined and it has been found that Dr. Deepika Sharma (Roll No. 6600059) has not been shortlisted for the post of GMC Kathua, however, she has been shortlisted for 01 post of GMC Anantnag, under OM category, where her merit is less than the selected candidate who has secured 56.35 points.

Now, therefore, the representation of Dr. Deepika Sharma (Roll No. 6600059), is disposed of being devoid of any merit.
