

1. Whereas, the J&K Public Service Commission conducted the **Written Test for filling up of post of Assistant Floriculture Officer in Floriculture, Gardens & Parks Department on 30.08.2024**; and
2. Whereas, the Provisional Official Answer Key was notified and uploaded on the official website of the Commission for information of the candidates on 30.08.2024, inter-alia notifying that, if any candidate feels that the keys to any of the questions is wrong/incorrect, he/she may prefer a representation/objection on the prescribed proforma to the Controller of Examinations within a period of three working days from the date of its notification, i.e. upto 04.09.2024 (5:00 p.m.) along with documentary proof /evidence and the fee of Rs. 500/- per question; and
3. Whereas, in response to the said notification, only 01 objection/representation was received by the J&K Public Service Commission against Provisional Official Answer Key issued; and
4. Whereas, the said objection/representation was referred to the Committee of Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time, for Independent Expert opinion; and
5. Whereas, the independent team of Experts have recommended **no change** in the Provisional Official Answer Key in respect of the said paper;

Now, therefore, in view of the above and on the basis of opinion of the independent team of Experts, the Final Official Answer Key is annexed to this notification as Annexure A.


