In pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examinations) Rules, 2022 read with Rule 31 and 43(ii) of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date, the candidates as per **Annexure-A** to this notification are hereby declared to have qualified for the Oral Test/Viva Voce for the post of Assistant Floriculture Officer in Floriculture, Gardens & Parks Department on the basis of their performance in the Written Test which was held on 30.08.2024. The notification with respect to the dates of Interview/Viva-Voce shall be notified separately.

Note:

- i. For checking the result, candidates are advised to access the official website of the Commission i.e. http://www.jkpsc.nic.in.
- ii. The candidature of candidates shown in Annexure –A is purely provisional. The documents of the candidates will be verified at the time of interview and in case any discrepancy with regard to age/qualification/experience and other eligibility conditions is noticed at the time of interview or thereafter, the candidate shall not be allowed to appear in the interview or where the candidate has already appeared in the interview, the candidature shall be deemed to have been cancelled *ab-initio*.
- iii. Only eligible candidates, possessing requisite qualification prescribed under rules, shall be allowed to appear in the Oral Test/Viva-Voce subject to the condition that they are within the prescribed age limit on the cutoff date.



iv. The candidates shall produce their original certificates/ testimonials on the date of oral test/Viva-Voce.

This is subject to the outcome of writ petition, if any, pending disposal before any competent Court of Law.
