01	Dr. Asif Mohiudd in Rather	1) The candidate Insha Majeed(OM) shown in the final selection list (S/No 4) of Assistant professor Horticulture technology has been given 5 points of PhD even when her PhD result was not declared till the cutoff date of eligibility and was not eligible to secure 5 points which is gross violation of recruitment rules. It is also pertinent to mention that her PhD degree certificate is issued only after the issuance of result notification.	I) As per the PhD certificate of Ms. Insha Majeed issued by Sher-e-Kashmir University of Agricultural Sciences and Technology of Kashmir, the selected candidate had completed all the prescribed requirements of degree on 31.05.2023 i.e., before the cutoff date of the advertisement notification.
		II) Mudasir Iqbal (OM) falling at serial No 3 in the Selection List of Assistant professor Horticulture technology possess M.Sc degree in Agriculture and not in Horticulture, which as per rules is not eligible for the said post. Previously Commission has rejected these degrees in the recruitment for the posts of Horticulture the details are enclosed for ready reference.	II) The SKUAST, Jammu vide Memorandur issued under No. Auj/Acad/F/18-19/7627-3 dated 27.02.2019, read with lette No.Auj/Acard/24-25/3919 dated 12.08.202 has clarified that the candidates possessin M.Sc Agriculture (Fruit Science) should be considered for the post of Assistant Professor Horticulture Technology.

04	Ejaz Ahmad paray	It is requested to verify the RBA category certificate of Imtiyaz Ahmad wani & Zehwa Jan as their family Ceiling income is well above the criteria for Reserved Baward Area (RBA Category). Imityaz Ahmad wani is working as Senior Assistant Handicrafts Training Officer w.e.f. 10.01.2014 – He is not eligible for RBA Category as per rules and also his father is working as a Bank Manager in SBI.	Issuance of category certificate is the domain of the concerned Tehsildar and PSC has no role in it.
05	Mousian Ahmd Hajam	Cross check the written Test marks and degrees of candidates in reference to provisional selection list of Assistant Professor, Horticulture Technology, the OMR marks comes to be different as reflected in the result published. The eligibility for the post was M.sc Horticulture with NET and I fulfilled the eligibility criteria required for the said post i.e M.sc Horticulture (Degree certificate enclosed) and provisional result was declared vide notification no 31-PSC (DR-S) of 2024 and I was shocked to see my result withheld, I don't know the reason. He has requested to release his withheld result.	The representation has been considered. However the candidate has secured 53.89 points which is less than the cut of merit under OM category.
