- 4. Whereas, all the objections/representations were referred to the Committees of Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time, for Independent Expert opinion; and
- 5. Whereas, the independent team of Experts have recommended changes in the Provisional Official Keys in respect of the said paper;

Now, therefore, in view of the above and on the basis of opinion of the independent teams of Experts, it is hereby notified that the changes recommended by the Committee of Experts are hereby adopted and the Final Official Key is annexed to this notification as Annexure-A.
