

Whereas, the Provisional official key was notified and uploaded on the official website of the Commission for information of the candidates on 15.09.2024, inter-alia notifying that, if any candidate feels that the keys to any of the questions is wrong/incorrect, he/she may prefer a representation/objection on the prescribed proforma to the Controller of Examinations within a period of three days from the date of its notification, i.e upto 19.09.2024 (5:00 PM) along with documentary proof/evidence and the fee of Rs. 500/- per question; and

4. Whereas, all the objections/representations were referred to the Committees of Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time, for Independent Expert opinion; and
5. Whereas, the independent team of Experts have recommended changes in the Provisional Official Keys in respect of the said paper;


