Rejection of candidature for the post of Assistant Professor Mathematics, in Higher Education Department.

Whereas, the Higher Education Department, vide letter No.HE/Coll/Coord/Apptt/A.P/2021 dated 05.07.2021 and No. HED-GAZ/85/2022-04 dated 13.03.2022, among others, referred 07 posts (OM=04, RBA=01, SC=01, ST=01) of Assistant Professor, Mathematics, in Higher Education Department, for selection; and,

Whereas, the posts were advertised, vide Notification No. 06-PSC (DR-P) of 2023 dated 15.05.2023; and,

Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 24.03.2023, among others, again referred 10 posts (OM=03, SC=01, ST=01, ALC/IB=01, Social Cost, 01, RBA=01, PSP=01, EWS=01) of Assistant Professor Mathematics, in Higher Education Department, for selection; and,

Whereas, these posts were advertised, vide Notification No. 17-PSC (DR-P) of 2023 dated 15.05.2023, and,

Whereas, the written test was conducted on 05.11.2023, and 68 candidates were declared to have qualified the written test provisionally, for both the above notifications, vide Notification No. PSC/Exam/S/2024/08 dated 01.04.2024; and,

Whereas, upon scrutiny of the documents, it was found that EWS category certificate, issued vide No. JK-REV-EWS/2023/05056 dated 20.04.2023, submitted by Mr. Sahil Sharma S/o Kherati Lal R/o Harsath, Ghagwal, Samba has been issued for jobs in the Central Government.

Whereas, report was called from Tehsildar Ghagwal, Samba, vide letter No. PSC/DR/AP-Math/Hr. Edu./2024 dated 14.10.2024, as to whether the EWS category certificate, issued vide letter No. No. JK-REV-EWS/2023/05056 dated 20.04.2023, submitted by Mr. Sahil Sharma S/o Kherati Lal R/o Harsath, Ghagwal, Samba can be considered for the jobs in UT of J&K.

Whereas, Tehsildar Ghagwal, Samba, vide letter No.OQ/TG/522 dated 28.10.2024, has conveyed that Mr. Sahil Sharma belongs to General Caste which is not recognized as a Scheduled Caste, Scheduled Tribe and Other Backward Classes under Central List. Moreover, the EWS certificate issued vide No. JK-REV-EWS/2023/05056 dated 20.04.2023 can be considered under EWS category for applying for appointment to posts under Government of India.

Now, therefore, the candidature of the Mr. Sahil Sharma S/o Kherati Lal R/o Harsath, Ghagwal, Samba (Roll No. 5800233), under EWS category, for the post of Assistant Professor, Mathematics, in Higher Education Department, is hereby rejected, as the EWS category Certificate produced by the candidate is not as per the stipulated format meant for the Jobs in UT of J&K.
