Whereas, Agriculture Production Department, vide letter No. ASH/Fish/22/2017 dated 09.06.2020, 21.12.2020 & 21.01.2021, referred two (02) posts (OM:01, RBA:01) of Fisheries Development Officer, in Agriculture Production Department, to the J&K Public Service Commission, for selection of suitable candidates and Commission, vide Notification No. 04-PSC (DR-P) of 2021 dated 16.04.2021, advertised the said posts for selection; **and,**

Whereas, written test was conducted on 28.05.2024. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/46 dated: 07.08.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021; **and,**

Whereas, Eleven (11) candidates were shortlisted against Notification dated 16.04.2021, 02 (two) candidates remained absent & 02 (two) candidates were found ineligible, as such interview of 07 candidates was conducted; **and,**

Whereas, the viva-voce of candidates was conducted on 7<sup>th</sup> of January, 2025 with the assistance of Experts from outside the UT of J&K.

Now, therefore, on the basis of the performance in the written test, interview, and other related parameters, in pursuance of Rule 43 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure-"A"** to this Notification.




