Whereas, Floriculture, Parks & Gardens Department, vide letter No. Flori/37/2013 dated: 29.09.2020, referred three (03) posts (OM: 01, RBA: 01, SC: 01) of Assistant Floriculture Officer, in Floriculture, Parks & Gardens Department, to the J&K Public Service Commission, for selection of suitable candidates and Commission, vide Notification No. 09-PSC (DR-P) of 2022 dated 26.04.2022, advertised the said posts for selection; and,

Whereas, written test was conducted on 30.08.2024. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/71 dated: 05.11.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021; and,

Whereas, Fourteen (14) candidates were shortlisted against Notification dated 26.04.2022, and interview of all 14 candidates was conducted; **and**,

Whereas, the viva-voce of candidates was conducted on 14th of January, 2025 with the assistance of Experts from outside the UT of J&K.

Now, therefore, on the basis of the performance in the written test, interview, and other related parameters, in pursuance of Rule 43 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure-"A"** to this Notification.

Consequent upon the details given here-in-above, Provisional Select List of the candidates for the post of Assistant Floriculture Officer, as per merit, is given in **Annexure-B** to this Notification.
