Whereas, written test was conducted on 29.08.2024. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/73 dated: 06.11.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021; **and,**

Whereas, Five (05) candidates were shortlisted against Notification dated 05.08.2022, and interview of all 05 candidates was conducted; **and,**

Whereas, the viva-voce of candidates was conducted on 21st of January, 2025 with the assistance of Experts from outside the UT of J&K.






