Whereas, Mining Department, vide letter No. GM-MNG/33/2022-04 dated 07.04.2022 & GM-MNG/33/2022-04 dated 18.04.2022, referred **One (01) post (OM: 01)** of Driller, in Mining Department, to the J&K Public Service Commission, for selection of suitable candidates and Commission, vide Notification No. 20-PSC (DR-P) of 2022 dated 05.08.2022, advertised the said posts for selection; *and*,

Whereas, written test was conducted on 29.08.2024. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/73 dated: 06.11.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021; *and*,

Whereas, Five (05) candidates were shortlisted against Notification dated 05.08.2022, and interview of all 05 candidates was conducted; **and**,

Whereas, the viva-voce of candidates was conducted on 21<sup>st</sup> of January, 2025 with the assistance of Experts from outside the UT of J&K.

Now, therefore, on the basis of the performance in the written test, interview, and other related parameters, in pursuance of Rule 43 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure-"A"** to this Notification.

Consequent upon the details given here-in-above, Provisional Select List of the candidate for the post of Driller, as per merit, is given in **Annexure-B** to this Notification.
