Subject: Provisional Select List for the post of Assistant Professor, Physiology, in Government Medical College Anantnag, Doda, Kathua & Rajouri in Health & Medical Education Department.

Whereas, the Health & Medical Education Department, vide letter Nos, MEGAZ-187/2014 dated 18.08.2021 read with ME-GZtd/317/2021 (e-office), dated 14.03.2022, ME-Gztd/56/2022 (e-office), dated 06.04.2022 and ME-Gztd/21/2022 (e-office), dated 07.07.2022, referred three (03) posts of Assistant Professor, Physiology, one each in GMC Doda, Kathua & Rajouri under Open Category, to the J&K Public Service Commission, for selection of suitable candidates; **and,**

Whereas, the said posts were advertised vide Notification No. 28-PSC (DR-P) of 2023 dated 08.06.2023. The cut-off date for determination of eligibility was fixed as 30.06.2023; **and,**

Whereas, again the Department vide letter Nos. ME-Gztd/246/2022-02 (CC: 7037074) dated 26.07.2023, and letter No: Me-Gztd/246/2022 e-office dated 05.12.2022, referred seven (07) posts in various GMCs to the J&K Public Service Commission, for selection of suitable candidates with the following break-up:-

GMC Anantnag (OM: 01), Baramulla (RBA: 01), Doda (RBA: 01), Kathua (RBA: 01) Handwara (RBA: 01), Udhampur (RBA: 01) and Rajouri (SC: 01).

Whereas, these posts were advertised vide Notification No. 35-PSC (DR-P) of 2023 dated 03.08.2023. The cut-off date for determination of eligibility was fixed as 19.08.2023; **and,**

Whereas, a written test was conducted on 21.06.2024. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/62 dated: 09.10.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; **and,**

Whereas, 05 candidates were called for interview for GMC Anantnag, 05 for GMC Doda, 05 for GMC Kathua and 05 for GMC Rajouri. Since, some candidates had applied against more than one post, as such, only 09 candidates had to be called for interview. 01 candidate bearing BD No.05 remained absent; **and,**


Whereas, the viva-voce of candidates was conducted on 23.01.2025, with the assistance of Experts from outside of UT.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 44 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure-A** to this Notification.

Consequent upon the details given here-in-above, the candidates whose particulars are given as **Annexure-B** to this Notification, are provisionally selected against the following posts:-

Note:-

1. The Commission reserves the right to have certificates/documents of the candidates verified, if at any later stage found expedient to do so. The selection of the candidates is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.
2. The selection is provisional and objections, if any, may be submitted to the Commission within five days for examination and disposal. No claim, whatsoever, shall be entertained after five days from the date of issuance of Notification.
3. The following posts remained unfilled due to non-availability of candidates/ candidates not crossing the Bench Mark as envisaged in Rule 51 of J&K Public Service Commission (Business & Procedure), Rules, 2021 :-
Baramulla (RBA: 01), Doda (RBA: 01), Kathua (RBA: 01), Handwara (RBA: 01), Udhampur (RBA: 01), Rajouri (RBA: 01). Among unfilled posts, 03 RBA posts 01 each in GMC Handwara, Udhampur and Rajouri were advertised in 1st Special Drive.
