

1. Whereas, the J&K Public Service Commission conducted the **Written Test for filling up of posts of Veterinary Assistant Surgeons 2024, on 12.01.2025; and**

Whereas, the Provisional Answer Key was notified and uploaded on the official website of the Commission for information of the candidates on 12.01.2025, inter-alia notifying that, if any candidate feels that the key to any of the question is wrong/incorrect, he/she may prefer an objection on the prescribed proforma to the Controller of Examinations within a period of three days from the date of its notification, i.e. upto 16.01.2025 (5:00 p.m.) along with documentary proof /evidence and the fee of Rs.500/- per question; and
