- iii. Only eligible candidates, possessing requisite qualification prescribed under rules, shall be allowed to appear in the Oral Test/Viva-Voce



subject to the condition that they are within the prescribed age limit on the cut-off date.

iv. The candidates shall produce their original certificates/testimonials on the date of oral test/Viva-Voce.

This is subject to the outcome of writ petition, if any, pending disposal before any competent Court of Law.
