Whereas, the said posts were advertised vide Notification No. 30-PSC (DR-P) of 2022 dated 30.12.2022. The cut-off date for determination of eligibility was fixed as 31.01.2023; **and,**

Whereas, written test was conducted on 25.05.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2023/30 dated: 06.07.2023, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; **and,**


Whereas, the viva-voce of candidates was conducted on 24.03.2025, with the assistance of Experts from outside UT.




